RESEARCH GRANTS ARE AVAILABLE TO THE SOCIETY'S MEMBERS AND THEIR TRAINEES THROUGHOUT THE UNITED STATES AND CANADA. SINCE THE PROGRAM'S INCEPTION, OVER 200 PEOPLE HAVE RECEIVED MORE THAN \$10M IN RESEARCH GRANT FUNDING. IN 2019, THE ASTS FOUNDATION AWARDED \$448K IN GRANT FUNDING TO 14 RECIPIENTS.
