CHALLENGE

- ◆ **No living donor should be discriminated against** in efforts to obtain, or maintain, disability or life insurance based solely on their decision to donate an organ & their decision to donate should not impact their job security.

SOLUTION

- ◆ **ASTS urges Congress to pass the Living Donor Protection Act (LDPA) of 2023 (H.R. 2923/S.1384)** to remove barriers to living organ donation by prohibiting discrimination in insurance & provide protection for living donors under the Family and Medical Leave Act (FMLA). [BILL TEXT](#)

THE LDPA: PROTECTING DONORS' ACCESS TO INSURANCE & EMPLOYMENT

- ◆ **Prohibits life, disability, and long-term care insurance plans** from denying or limiting coverage & from charging higher premiums for living organ donors.
- ◆ **Amends the Family & Medical Leave Act of 1993** to specifically include living organ donation as a serious health condition for private and government employees.
- ◆ **Directs the U.S. Department of Health and Human Services (HHS)** to update their materials on live organ donation to reflect these new protections & encourage more individuals to consider donating.

SUMMARY OF POLICY PRINCIPLES & SOLUTIONS: LIVING ORGAN DONATION

As the leading national organizations representing patients, organ donors, transplant surgeons, and other transplant health professionals, the ASTS, the American Association of Kidney Patients (AAKP), and the American Society of Transplantation (AST) published a set of guiding principles regarding living organ donation in April 2023.

ASTS, AAKP, and AST share the broad-based societal goal of increasing the organ donor pool and organ transplantation, but caution policymakers that proposed changes to living donation involve a complex set of legal, ethical, and clinical concerns that are well-documented in medical literature and federal agency and Congressional proceedings and that would put advanced in the field at risk.

SAFEGUARD PATIENT HEALTH AND SAFETY; PREVENT FINANCIAL COERCION

ASTS, AAKP, and AST strongly support the elimination of disincentives to transplantation and adamantly oppose coercive financial incentives to donate.

We strongly support legislation to protect patient from insurance discrimination or fear of losing their employment. We advocate for programs that offer public or private financial support as a means of removing financial disincentives for those wishing to donate an organ.

OVERREGULATION OF LIVING DONATION PRESENTS SERIOUS DANGERS

ASTS, AAKP, and AST believe that improvements to the transplant system can best be made through ethically and legally sound, evidence-based, data driven policies informed and guided by patients and transplant professionals rather than by overhauling the entire transplant system.

We oppose policy efforts that seek to place any governmental entity in the position of determining clinical criteria for living donor transplantation or otherwise interfering with the relationship between and among potential recipients, potential donors, and their caregivers.

ASTS, AAKP, and AST believe that the best ways to greatly increase access to living donor transplantation are to remove disincentives to transplant, foster innovation in transplant, increase commitment to transplant research, and improve Medicare transparency and access to transplantation.
