

CMS Releases 2026 Physician Fee Schedule Final Rule

On October 31, 2025, the Centers for Medicare & Medicaid Services (CMS) issued a final rule that announces final policy changes for Medicare payments under the Physician Fee Schedule (PFS), and other Medicare Part B issues, effective on or after January 1, 2026. The 2026 Final Medicare allowances for transplant procedures are provided on the accompanying spreadsheet.

As required by statute, beginning in CY 2026, there will be two separate conversion factors: one for qualifying alternative payment model (APM) participants (QPs) and one for physicians and practitioners who are not QPs. The final CY 2026 qualifying APM conversion factor of \$33.57 represents a projected increase of \$1.22 (+3.77%) from the current conversion factor of \$32.35, and the final CY 2026 nonqualifying APM conversion factor of \$33.40 represents a projected increase of \$1.05 (+3.26%) from the current conversion factor of \$32.35.

In the 2026 PFS Final Rule, CMS also finalized a number of policy changes of interest to ASTS members. The bad news is:

- CMS finalized an "efficiency adjustment" that would apply to the work Relative Value Unit
 (RVU) and corresponding intraservice portion of physician time of non-time-based services,
 including transplant surgery. Under this new policy, the work time associated with many
 services (including transplant and other surgery) is reduced by 2.5%, to account for
 presumed efficiency improvements over the past five years.
- CMS finalized a proposal to adjust the methodology for allocating indirect costs (such as
 overhead, billing, administrative costs, etc.) based on the site of service. Specifically, for
 services valued in the facility (e.g. hospital inpatient) setting, CMS is reducing the indirect
 costs to half the amount used for non-facility services (i.e. services performed in
 physicians' office settings). Since transplant procedures are performed in a facility setting,
 this new policy impacts the RVUs for transplant procedures in 2026 and future years.

The good news is:

- CMS finalized its proposal to permanently allow direct supervision via real-time audio/video for services provided incident to physicians' services and diagnostic services and also finalized changes that will make it easier to add new services to the telehealth list.
- As the result of comments submitted by ASTS and others, CMS changed the position it took in the proposed rule and will extend through 2026 a policy that allows teaching physicians to have a virtual presence for purposes of billing for services furnished involving residents in all teaching settings, which was to have expired on December 31, 2025.
