Call to Order | Presenter: Timothy Pruett, MD

Discussion:

• Dr. Pruett presented the agenda for the meeting. He also presented the mission and vision statements, the strategic goals, and core values.

Discussion:

- Dr. Kaufman presented the Secretary's report.
- Dr. Ratner presented the Treasurer's report, including the 2016 audited financial report as of December 31, 2016. The Society has achieved its \$20 million goal, with caveats, ahead of schedule (2020).
- Dr. Pelletier presented the bylaws changes regarding the candidates on the ballot for election of the President-Elect in the fast track year. An amendment was suggested that the wording be "up to 3 names" instead of 3 names. The amendment was rejected by the originator of the motion.
- Dr. Rocca presented the Society's membership statistics.

Motion:

- To approve the minutes from the June 14, 2016, Business Meeting. The motion was seconded and approved by unanimous vote.
- To approve the changes to the bylaws language as presented. The motion was seconded and was approved by unanimous vote.

Leadership Perspectives | Presenter: Timothy Pruett, MD

Discussion:

Dr. Pruett gave an overview of the past year for ASTS, including the TACC and Foundation changes.
He introduced a video of officers, councilors, and committee chairs indicating projects or initiatives
over the past year of which they are proud. He asked for a round of applause for all the people
doing the work of the Society.

Discussion:

- Dr. Pomposelli paid tribute to Dr. Gordon as the past chair of the Legislative Committee and presented recent advocacy initiatives, including the new combined Legislative/Regulatory Committee.
- Dr. Miller reported on the Foundation's recent initiatives, including a new vision statement: promoting philanthropy in the field of transplant surgery. He announced the guaranteed annual funding for grants and new recognition levels for annual and lifetime giving and recognized Tom and Ruby Peters as the first members of the Starzl Club. He thanked all the contributors to the Foundation and urged everyone to give their colleagues a chance to give. He announced that he and Erica have decided to become members of the Starzl Club, introduced the members of the President's Club, and presented the 2016 and 2017 contributors.
- Dr. Pruett congratulated Ms. Smith on becoming the first councilor representing ATP members. Ms. Smith presented a report on ATP engagement in Society activities.
- Dr. Fryer reported on ASTS' expanded educational portfolio.
- Dr. Hirose gave an update on fellowship training activities, including creation of the Transplant
 Accreditation and Certification Council. Dr. Pruett thanked Drs. Fryer and Hirose and all those
 involved in ASTS' educational and training activities. Ms. Kulikosky announced ALDP registration is
 open and encouraged anyone who is interested to register soon. Dr. Hirose thanked Ms. Gordon for
 her work with fellowship training.
- Dr. Baker gave an update on living donor resources, noting NLDAC's ten-year anniversary. She thanked NLDAC for their work helping living donors.
- Dr. Sung gave an update on organizational culture, including core values development and a continued focus on mission, vision, and strategic goals.
- Dr. Stock recognized Dr. Simmons, the Pioneer Award recipient; Dr. Kenneth Moritsugu, the newest honorary member; and recipients of ASTS awards. He also recognized Ms. Gifford for her talents and all the Society members for their dedication.
- Dr. Chavin presented professional resources for ASTS members.
- Dr. Bumgardner presented the Society's research activities over the past year.
- Dr. Peters commented that ASTS' seat in the AMA is important for advocacy effort and urged everyone to become or remain members of the AMA.

- Dr. Pruett presented the names of those who have passed away since the last ATC. He called for a moment of silence, which was observed.
